**Explanation of Responses:**

- These restricted shares fully vested on March 15, 2010, based on the Issuer's achievement of certain financial milestones. The transactions in this Form 4 represent the portion of these shares sold.
- One-quarter of this option grant vested on March 30, 2007, with the remaining options vesting at 2.083% per month on the first day of each month for the next 36 months.
- One-quarter of this option grant vested on October 1, 2008, with the remaining options vesting at 2.083% per month on the first day of each month for the next 36 months.
- Twenty-five percent of this option grant vested on October 1, 2009 and thereafter 1/48th of the option grant will vest each month for thirty-six months.
- Twenty-five percent of this restricted stock grant will vest on October 1, 2010 and thereafter 1/4th of the restricted stock grant will vest on October 1 of each year for three years.
- Twenty-five percent of this option grant will vest on October 1, 2010 and thereafter 1/48th of the option grant will vest each month for thirty-six months.
